

**COPPER MOUNTAIN FOUNDATION

ELIGIBILITY: Open to original enrollees of The Tatitlek Corporation (TTC) and lineal descendants of original enrollees (by birth or adoption). The Copper Mountain Foundation provides a limited number of grants to promote Tatitlek Corporation shareholder or descendant youth participation in programs which promote education or preservation of Tatitlek Native culture and traditions, art, history and language.

AMOUNT: Grants are limited to a maximum of \$250 per shareholder or descendant participating in the program, with a limit of \$1,000 per program. Larger grants will require board approval. Payment will be made directly to the school or program providing the youth activities.

- Letter From Student (stating what they hope to gain from the program)
