



SCHOLARSHIP APPLICATION

ELIGIBILITY: Applicants must be an original shareholder or lineal descendant (by birth or adoption) of an original shareholder of The Tatitlek Corporation (TTC). All lineal descendants must be registered in The Tatitlek Corporation with complete documentation.

FUNDING LEVELS: Scholarships for tuition, fees, on-campus housing, books & materials will be available to eligible students. Students must be enrolled in an accredited university. Funds are paid by the Copper Mountain Foundation directly to the institution. Full-time Undergraduate students are eligible for up to \$9,000 annually. Full-time Graduate students are eligible for up to \$12,000 annually. Students attending less than full-time will receive a pro-rated amount.

Students must maintain a cumulative GPA of 2.0 for undergraduate degrees, and 3.0 for graduate degrees, or remain in good standing if the academic or training institution does not grade courses.

UNOFFICIAL TRANSCRIPTS: The student must provide unofficial transcripts to Copper Mountain Foundation each term showing a cumulative and current GPA total or proof of good standing (for non-graded programs) to continue receiving funding.

PROBATION: Students must complete all courses they receive funding for in addition to maintaining the minimum cumulative GPA required for their degree program. Failure to meet this obligation will place the recipient's scholarship on hold for the next funding period. If these terms are not met while on the probationary period, funding for the next period will not be granted until terms have been met.

DEADLINES: Student must submit an application for each school period. Copper Mountain Foundation does not provide reimbursements or retroactive funding. Scholarships will be processed within 15 business days.
